



# Manor Park Primary Pupil Premium Funding



## What is Pupil Premium Funding?

*Registering your child for free school meals does not just give your child a free lunch...*

Your school could get up to £1,320 per year from the government for each child from a family on a low income. This is called Pupil Premium and can be used to support your child with their learning and the provision of extra-curricular activities.

For every child registered for Free School Meals the school currently receives £1,320 Pupil Premium funding....

Even if you think you will only be eligible for a free school meal for a short time, the school will still continue to generate Pupil Premium for your child....

We need **ALL** eligible pupils to register for Free School Meals; even those in Reception, Y1 and Y2 who already have Universal Infant Free School Meals.... \*As well as Pupil Premium for families on low income, schools are allocated up to £2,300 each for Looked after Children/Post-Looked after Children. For families with a parent in the Services, schools are allocated up to £300 each.

## Do You Qualify?

YOU CAN CLAIM FOR THE PUPIL PREMIUM IF YOU RECEIVE ANY OF THE FOLLOWING:

- Income Support or Employment and Support Allowance (Income-related)
- Income-based Jobseekers Allowance
- Child Tax Credit with an annual household income below £16,190 and not receiving Working Tax Credit
- Support under part VI of the Immigration and Asylum Act 1999
- Guarantee element of State Pension Credit.
- Children of Service Personnel
- Children who have been adopted or who are currently looked after

OR ANY FAMILY ENTITLED TO UNIVERSAL CREDITS WITH A FAMILY INCOME UNDER £7,400 NET PER YEAR.

## What are the benefits?

- Half price trips and visits, including residential visits
- Reduced price extra-curricular sessions
- A £25 Asda voucher for all new eligible families
